

Dear Members of the Arcata City Council,

On August 22, 2021 a group of health freedom advocates staged a rally in front of St. Joseph's Hospital. One of the people brought some buttons to share. The buttons have a yellow star on them with the word "Unvaccinated" in the center of it. The inspiration to both make the buttons and to wear them came from being treated in similar ways to how the Jews were treated in the early stages of the Holocaust, being alienated, discriminated against, persecuted, forced to lose their employment, feared and treated as 2nd class citizens and worse. We unvaccinated have also been labeled conspiracy theorists because we have done our research and the information we have found is censored so everyone else is in the dark, and are afraid to consider that it may all be the truth. We in the health freedom/freedom movement do not understand how everyone else cannot see what is happening. We have seen friends and family not defend us or have a problem with the treatment that we have received, just like so many people in Germany stood by and watched as the treatment of the Jews grew worse and worse. Since the beginning of Covid-19, there have been so many violations of the Nuremberg Code, and yet I do not hear anyone speaking out about this except for those of us in the health freedom movement.
